- 1. HOW TO ENTER
 - a. These rules govern the FM 100.3 Payroll 2020 Contest ("Contest"), which is being conducted by KSFI-FM ("Station"). The Contest begins on April 6, 2020 and ends on May 1, 2020 ("Contest Dates"). Entrants, as defined below, may enter via online only.
 - b. To enter the Contest, the person entering the Contest ("Entrant") may enter online beginning on April 6, 2020 at 12:00 a.m. (MDT) and ending on May 1, 2020 at 4:20 p.m. (MDT) ("Entry Period") as follows:
 - i. To enter online, visit <u>https://fm100.com/</u> and follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above. Online Entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy and Terms of Use. Only one (1) entry per eligible Entrant during the Entry Period regardless if Entrant has more than one email address. Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Station.
 - ii. Beginning on April 13, 2020 starting at 8:20 a.m. (MDT) and ending on Friday, May 1, 2020 at 4:20 p.m. (MDT), tune in to the Station weekdays at 8:20 a.m. (MDT), 12:20 p.m. (MDT) and 4:20 p.m. (MDT) and listen for the on-air personality to announce one of the Entrant names submitted via online entry. If Entrant hears his or her name announced on-air, Entrant will have fifteen (15) minutes to call back the Station contest lines: (801) 470-1100; (801) 570-1100; or (801) 670-1100 and

will win a prize upon confirmation of eligibility and be put "on the clock" to potentially win more prizes. When an Entrant is placed "on the clock," if the Entrant whose name is selected for the next time slot does not call the contest lines within fifteen (15) minutes, then the "on-the-clock" Entrant will win the prize for that time slot in addition to the prize for the time slot at which the Entrant's name was selected. - d. Entrants may be provided with opportunity opt-in for an to membership/participation part of the entry but as process, membership/participation is not required to enter the contest.
- e. Only one (1) entry per Entrant is permitted. There will be up to a total of fifteen (15) winners selected in the Contest.

f. All online entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older, and make up the listening area in Utah. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (i) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation to such a such and partners.
- c. The Winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). Prizes are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for credit at any time, nor will they be replaced if lost or stolen.
- b. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the Winner(s). Prizes are not transferable or exchangeable and may not be substituted, except by Contest Sponsor for reasons of unavailability, in which case, a prize of equal will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station is not responsible for replacing prizes that have been awarded. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
- c. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. Fifteen (15) Winners will be selected on-air as described above in Section 1 of these Official Rules.
- c. Odds of winning depend upon the number of eligible online entries and the number and order of eligible phone calls received.
- d. Winners must listen to the Station to win but do not need to be present to win. All prizes may be picked up or claimed within thirty (30) days, as directed by the Station, including in-person, if public health conditions permit, at the office of the Station located at 55 North 300 West, Salt Lake City, Utah 84180 between regular business hours of 8:00 a.m. (MT) to 5:00 p.m. (MT), Monday through Friday. If public health conditions do not permit a Winner to claim the prize in person within thirty (30) days, the Station will coordinate with the Winner to confirm Winner's identity remotely and to deliver the prize by mail or other means of delivery.

e. Potential Winner(s) will be notified of winning by telephone. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers.
