#### 2.1. HOW TO ENTER

a. These rules govern the FM 100.3 One Hundred Degrees 2020 ("Contest"), which is being conducted by KSFI-FM ("Station"). The Contest begins on June 22, 2020 and ends on July 17, 2020 ("Contest Dates"). Entrants, as defined below, may enter via online only.

b. To enter the Contest, the person entering the Contest ("Entrant") may enter online beginning on June 22, 2020 at 12:00 ~~AM~~a.m. (MDT) and ending on July 17, 2020 at 11:59 p.m. (MDT) ("Entry Period") as follows:

i. To enter online, visit <https://fm100.com/> and follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above. Online Entrants are subject to all notices posted online including but not limited to the Station's Terms of Use and Privacy Policy. Only one (1) entry per eligible ~~person~~Entrant during the Entry Period regardless if Entrant has more than one email address. Multiple ~~participants~~Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the ~~Contest Administrator~~Station.

ii. The online entry form will consist of the Entrant's guess of the exact date and time that Salt Lake City, Utah will hit one hundred degrees

(100°F) for the first time in 2020. The official temperature sensor for this Contest will be the thermometer located at the Salt Lake City Airport.

- c. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.
- d. Only one (1) entry per person-Entrant is permitted. There will be up to a total of one (1) winner selected in the Contest.
- e. All online entries must be received by the end of the Entry Period.

### 3.2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older, and who reside in one of the jurisdictions that make up the listening area of Utah. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (i) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) Any immediate family members of such employees, including without limitation current, and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. These restrictions also apply to immediate household members of contest or prize winners.

- e. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any Entrant who does not meet the eligibility requirements and will also delete any entry as required by law.
- f. This Contest is subject to all applicable federal, ~~state~~ and local laws and regulations. By participating and/or acceptance of prize(s), Entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.

~~e.d.~~ **If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.**

#### 5.4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. - c. In the event of any tie, the tie breaker will be determined from among all tied potential winners. The ~~Contest Administrator~~Station will at ~~their~~its sole discretion, make the final decision by selecting a winner at random from among all tied potential Winners. Decisions of the ~~Contest Administrator~~Station are final and binding.
- d. One (1) ~~prize w~~Winner will be selected on July 20, 2020 by 2:00 p.m. (MDT).
- e. Odds of winning depend upon the number of eligible online entry forms received during the applicable Entry Period.

competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.

- c. Calling the Station regarding the Contest constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Contest may be taped without further permission from the caller. The Released Parties are not responsible for: (i) typographical or other errors in the printing, the offering, or the administration of the Contest or in the announcement of a prize; (ii) incorrect or inaccurate information, human error, failure, or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, illegible, incomplete, or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals or signal interference, accidental disconnection, equipment malfunctions, and any other technological failures; or (vi) any cancellations, delays, diversions, or substitutions or omissions by any transportation providers or any other persons or entities providing any services to Entrant(s) and/or Wwinner(s) including any results thereof such as changes in services or location necessitated by same.
