There will be no cue to call on Labor Day (September 7, 2020). Upon hearing the cue to call, the tenth (10th) designated caller (as announced by the on-air personality prior to the cue to call) to get through to the Station Contest line: 801.575.1100, at 8:20 a.m. (MDT), 9:20 a.m. (MDT), 11:20 a.m. (MDT), 1:20 p.m. (MDT), and 4:20 p.m. (MDT) will be qualified for a chance to win a grand prize upon confirmation of eligibility ("Qualifying Winner"). The grand prize winner ("Grand Prize Winner")~~(s)~~ will be announced daily on the following day (Friday ~~qualifiers~~ Qualifying Winner will be contacted on the following Monday) after qualifying and contacted by phone by the on-air personality at 7:50 a.m. (MDT). At the time of Entrant's call, Entrant will be required to provide all information requested including Entrant's full name, complete address (including zip code), day and evening phone numbers, email address, and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully

makes it through on the Contest lines and completes the call will be a Qualifying Winner. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

e.e. Only one (1) entry per Entrant is permitted. There will be up to a total of seventy-five (75) Qualifying Winners and fifteen (15) Grand Prize Winners selected in the Contest.

e.f. All entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older, and who reside in one of the jurisdictions that make up the listening area of Utah. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (i) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

- e. Potential Qualifying Winner(s) and Grand Prize Winners will be notified of winning by telephone.
