- b. To enter the Contest, the person entering the Contest ("Entrant") may enter online beginning on September 21, 2020 at 12:00 a.m. (MDT) and ending on October 2, 2020 at 11:59 p.m. (MDT) ("Entry Period") as follows:
  - i. To enter online, visit <a href="https://fm100.com/">https://fm100.com/</a> and follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above. Online Entrants are subject to all notices posted online including but not limited to the Station's Terms of Use and Privacy Policy. Only one (1) entry per eligible Entrant during the Entry Period regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Station.
  - ii. The online entry form will consist of the Entrant's first name, last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address and the Entrant's vote for their favorite of Utah's best local frozen yogurt or ice cream shops. Each day during the Entry Period an Entrant will be able to visit the Station's website at <a href="https://fm100.com/">https://fm100.com/</a> vote for their favorite of Utah's best local frozen yogurt or ice cream shops between two (2) listed Utah's frozen yogurt or

ice cream shops. The Utah frozen yogurt or ice cream shop that receives the most votes will move onto the next round. There will be a total of five (5) rounds. Click on the Station's website each day during the Entry Period to see which of your favorite Utah frozen yogurt or ice cream shop has taken the lead and ultimately wins. All Entrants that vote in this Contest will be entered to win the grand prize.

- c. Entrants be provided with opportunity opt-in for may an membership/participation as part of the entry process. but membership/participation is not required to enter the contest.
- d. Entrant's my vote up to a total of five (5) times in the Contest. However, only one (1) entry will be recorded per Entrant no matter how many times an Entrant votes. There will be up to a total of one (1) winner selected in the Contest. Only one (1) winner, per household for the duration of this Contest is permitted. To avoid any confusion, an Entrant can only be a winner once in this Contest.
- e. All online entries must be received by the end of the Entry Period.

### 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, twenty-one (21) years of age or older, and who reside in one of the jurisdictions that make up the listening area in and around Salt Lake City, Utah. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (i) any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) any immediate family members of such employees, including without limitation current and/or exspouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. # 4. PRIZES

- a. One (1) prize will be awarded. The Approximate Retail Value ("ARV") of the prize is \$886.00. The tickets to Thriller must be used prior to October 31, 2020. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station and Contest Sponsor are final.
- d. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

### 5. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management and Contest Sponsor with respect to the Contest are final.
- b. In the event of any tie, the tie breaker will be determined from among all tied potential Winners. The Station will at their sole discretion, make the final decision by selecting a Winner at random. Decisions of the Station and Contest Sponsor are final and binding.
- c. One (1) Winner will be selected on October 5, 2020 by 2:00 p.m. (MDT) of all eligible entries.
- d. Odds of winning depend upon the number of eligible online entries received during the Entry Period.
- a. Winners do not need to listen to the Station or be present to win. All prizes must be picked up or claimed within thirty (30) days of winning, as directed by the Station, including in-person, if public health conditions permit, at the office of the

Station located at 55 North 300 West, Salt Lake City, Utah 84180 between regular business hours of 8:00 a.m. (MT) to 5:00 p.m. (MT), Monday through Friday. If public health conditions do not permit a Winner to claim the prize in person within thirty (30) days, the Station will coordinate with the Winner to confirm Winner's identify remotely and to deliver the prize by mail or other means of delivery. If the Winner chooses to have a prize shipped, the Winner will be required to sign a release that the Station and any Released Parties (defined below) are not responsibility if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping. In such cases, there is no purchase necessary to enter or win, except for reasonable postage and handling fees the amount of which shall not exceed \$1.50 plus the actual cost of postage to ship the prize.

The Station's computer or telephone system is the official time keeping device for this Contest. In the event of a dispute, all entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address; or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an Entrant's disqualification

- and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an Entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that Entrant from entering and/or winning this and any or all future Station-administered contests and seek damages to the fullest extent permitted by law.
- The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Contest, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the Contest, any such material changes will be broadcast on the Station and/or posted on its website: https://fm100.com/ within twenty-four (24) hours of the change and periodically thereafter. If due to circumstances beyond the control of the Station, any prize related location is closed, or competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled due to weather, natural disasters, disease, epidemic, pandemic, national or regional emergency, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.
- c. Calling the Station regarding the Contest constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Contest may be taped without further permission from the caller. Utah law governs the interpretation and construction of these Official Rules and all aspects related thereto.

a.
