Upon hearing the cue to call, the tenth (10th) designated caller (as announced by the on-air personality prior to the cue to call) to get through to the Station Contest line: 801.575.1100, at 9:20 a.m. (MDT), 12:20 p.m. (MDT), and 3:20 p.m. (MDT) will win a qualifying prize ("Qualifying Prize Winner"), and be qualified for a chance to win a grand prize ("Grand Prize Winner") upon confirmation of eligibility. The Grand Prize Winner will be contacted by phone, no later than November 2, 2020 at 5:00 p.m. (MDT). At the time of Entrant's call, Entrant will be required to provide all information requested including Entrant's full name, complete address (including zip code), day and evening phone numbers, email address, and date of birth in order to be eligible to win. THE GRAND PRIZE IS AWARDED "AS IS" AND THE STATION AND CONTEST SPONSOR DO NOT MAKE (AND ARE NOT RESPONSIBLE FOR) ANY REPRESENTATIONS, GUARANTEES, OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, IN FACT OR IN LAW, RELATING TO THE GRAND PRIZE (INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE), AND ALL SUCH WARRANTIES ARE HEREBY DISCLAIMED.
- d. As indicated above, all sales, prizes and other taxes, gratuities and any other incidentals associated with the prize are the sole responsibility of the Qualifying Prize Winners and Grand Prize Winner.
