1. HOW TO ENTER

- a. These rules govern Best In Class ("Contest"), which is being conducted by KSFI-FM ("Station"). The Contest begins on October 12, 2020 and ends on November 20, 2020 ("Contest Dates"). Nominators, as defined below, may enter online only.
- b. To nominate a teacher for entry in the Contest, the person submitting the teacher's name ("Nominator") may nominate a teacher ("Teacher") by entering online beginning on October 12, 2020 at 12:00 a.m. (MDT) and ending on November 20, 2020 at 11:59 p.m. (MST) ("Entry Period") as follows:
 - i. To enter online, visit https://fm100.com/ and follow the links and instructions to enter the Contest and complete and submit the online entry form ("Submission") during the Entry Period outlined above. Online Submissions are subject to all notices posted online including, but not limited to, the Station's Terms of Use and Privacy Policy. All Submissions must include a short essay (the "Essay") which should contain a maximum of 500 words that tell the Station why the nominated Teacher has made a difference in their school or community, and why he or she deserves to be the "Best In Class." Each Nominator may enter only one (1) Submission per eligible Teacher, regardless if Nominator has more than one email address. Multiple Nominators are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Submissions submitted may not be acknowledged or returned. Proof of entry of a Submission shall not be deemed proof of receipt by the Station.

- ii. Submissions must be accompanied by the following information:
 - 1. Nominator's full name.
 - 2. Nominator's address.
 - 3. Nominator's day and evening phone numbers.
 - 4. Nominator's date of birth.
 - 5. Nominator's e-mail address.
 - 6. Name of the Teacher being nominated.
 - 7. The Teacher's school.
 - 8. The school's city and phone number.
 - 9. Nominator's relationship to the Teacher.
- c. Only one (1) Submission per Nominator per eligible Teacher is permitted. There will be up to a total of six (6) winners selected in the Contest. A winner is defined as the person(s) who has been deemed eligible by the Station to win a prize ("Winner"). Only one (1) Winner, per household for the duration of this Contest is permitted. To avoid any confusion, an Teacher can only be a Winner once during this Contest.
- d. The Station may discard any Submission that it deems suspicious, objectionable or in poor taste, as determined by the Station in its sole discretion.
- e. All Submissions must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older, and who reside in one of the jurisdictions that makes up the Utah listening area. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station Contest, even if such individuals meet the age and residency requirements above: (i) any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) any immediate family members of such employees, including, without limitation, current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) any other individual legally residing in the same household (i.e., at the same address) of such employees, including, without limitation, roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, in its own discretion, persons who have previously won a prize (cash, services, merchandise) from a Contest or Station event from any of the Bonneville International Radio Stations are subject to the

- following restriction: These restrictions also apply to immediate household members of the Winner(s).
- d. To claim a prize, the Winner must provide valid government-issued photo identification and provide their complete address, date of birth and phone number, email address and Social Security Number.
- e. Nominators are required to provide truthful information and the Station will reject and delete any Submission that it discovers to be false or fraudulent. The Station will disqualify any Submission that does not meet the eligibility requirements and will also delete any Submission as required by law.
- f. This Contest is subject to all applicable federal, state, local laws and regulations. By participating and/or acceptance of prize(s), Nominator agrees to comply with these Official Rules and the decisions of the Station and Contest Sponsor, which are final and binding in all respects.

3. JUDGING CRITERIA

- a. A judging panel consisting of Bonneville Salt Lake employees will judge the Essay ("Judges"). The Judges will select six (6) total Submissions from among all eligible Submissions based on the following criteria ("Judging Criteria"): (1) an exceptional act of leadership (34%); (2) demonstrating outstanding virtue or selflessness (34%); and (3) inspiring greatness in their school or local community (32%). Once the Judges select each Winner the Teacher will be contacted by the Station to confirm accuracy of all the information provided in the Submission. Once accuracy of the Submission is confirmed, the Teacher must provide consent and a photograph (photograph criteria listed below) of the Winner for the Submission to be eligible to receive the prize.
 - i. Photographs must be of the nominated Teacher only. Any photographs that include sculptures, statues, architecture, paintings, and other works of art will not be accepted. When photographing the work of others, it must be as an object in its environment and not a full-frame close-up of another person's art.
 - ii. The photograph, in its entirety, must be a single work of original material owned by either the Nominator or Teacher. By entering the Contest, the Nominator and Teacher represents, acknowledges, and warrants that the submitted photograph is an original work created solely by either the Nominator or Teacher, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph. By entering the Contest and/or acceptance of prize(s), the Nominator and Teacher acknowledges, and warrants that the submitted photograph may be used by the Station and Contest

Sponsor on their owned-and-operated website/social media channels for marketing the Contest.

iii. The photograph must not contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.

4. TIE BREAKER

a. In the event of a tie for a prize, the tie breaker will be determined by a random drawing from all tied potential Winners by the Contest Sponsor. The Contest Sponsor, at its sole discretion, shall make the final decision to resolve any tie.

5. PRIZES

- a. Six (6) prizes will be awarded. Each prize consists of the following: one (1) check in the amount of \$500 payable to the selected Teacher. Approximate Retail Value ("ARV") of the prize is \$500 in total, with \$500 going to the individual Teacher. Transportation costs are excluded in the given price. Any difference between stated value and actual value will not be awarded. The Winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize consists only of the elements expressly set forth above; no other elements or expenses are included in the prize and all such expenses are the sole responsibility of the Winner. Prizes are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for credit at any time, nor will they be replaced if lost or stolen. If a prize is unable to be awarded or used or a prize-related event is unable to take place as scheduled, for reasons including, but not limited to, promoter or performer actions, cancellation, preemption, postponement or unavailability due to the closure of a Contest Sponsor's location, if applicable, or weather, natural disasters, disease, epidemic, pandemic, national or regional emergency, or for any reason beyond the control of the Station or Contest Sponsor if applicable, their sole responsibility to the Winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). Upon awarding the prize, the Station or Contest Sponsor will have no further obligation to the Winner(s).
- b. As indicated above, all sales, prizes and other taxes, gratuities and any other incidentals associated with the prize(s) is the sole responsibility of the Winner(s). As noted above, prizes are not transferable or exchangeable and may not be substituted, except by the Station or Contest Sponsor for reasons of unavailability, in which case, a prize of equal value will be awarded. The Station and Contest Sponsor assume no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the

Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station and Contest Sponsor are final.

c. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level; the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

6. WINNER SELECTION AND NOTIFICATION

- Decisions of the Station management and Contest Sponsor with respect to the Contest are final.
- b. Six (6) Winners will be selected as described above.
- Odds of winning a prize depend upon the number of eligible Submissions received during the applicable Entry Period.
- d. Winners do not need to listen to the Station or be present to win. All prizes must be claimed within thirty (30) days of winning, as directed by the Station. Prizes cannot be claimed by third parties on behalf of the Winner. Public health conditions do not permit a Winner to claim the prize in person, so the Station will coordinate with the Winner to confirm his or her identify remotely and deliver the prize by mail or other means of delivery. The Winner must have their prize shipped and will be required to sign a release that the Station and any Released Parties (defined below) are not responsibility if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping. There is no purchase necessary to enter or win.
- e. Potential Winner(s) will be notified of winning by email or telephone. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. Nominator and Teacher agree that this Contest shall be subject to and governed by the laws of the State of Utah and the forum for any dispute shall be in Salt Lake City, Utah. To the extent permitted by law, the right to litigate, to seek injunctive relief or to make any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Contest are hereby excluded and any Nominator and Teacher expressly waives any and all such rights. Certain restrictions may apply. Submissions are void if the Station determines the photograph to not be an original, or if the Submissions are incomplete, inaccessible or blocked, corrupted, damaged, irregular, altered, counterfeit, produced in error or obtained through fraud or theft.
- b. By entering, Nominator and Teacher also agree (i) to be bound by these Official Rules; (ii) that the decisions of the Station and Contest Sponsor are final and binding with respect to all matters relating to the Contest; and (iii) if the nominated Teacher wins the Released Parties (defined below) may use the Teacher's photographs and each Winner's name, photograph, likeness, and/or voice in any publicity or advertising relating to the Contest or future promotions without compensation or approval (except where prohibited by law).
- c. Any attempt by any Nominator to obtain more than the stated number of Submissions by using multiple/different email addresses, identities, registrations and logins or any other methods may void that Nominator's Submission and that Nominator may be disqualified. The use of any device to automate Submission is prohibited. Any use of robotic, repetitive, automatic, programmed, or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all Submissions by that Nominator at the Station's discretion. The Station's computer or telephone system is the official time keeping device for this Contest. In the event of a dispute, all Submissions will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address; or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in a Nominator's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an Nominator has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that Nominator from entering and/or winning this and any or all future Station-administered Contest and seek damages to the fullest extent permitted by law.

- d. - e. Calling the Station regarding the Contest constitutes permission for the Station to tape the caller's voice and use it on the air. All telephone calls during the Contest may be taped without further permission from the caller. By entering the Contest and/or acceptance of prize(s), all Nominator's and Teacher's consent to the use of their name, photograph, likeness, biography, voice, video, entry materials, prize information (if any), or any statements made for trade, publicity, advertising, or promotional purposes, in any and all media, now known or hereafter devised, including online announcements, without limitation and without compensation, except where prohibited by law.
- f. Each Winner will be required to produce identification satisfactory to the Station. - g. a. Each Nominator and Teacher represent and warrant as follows: (i) except as set forth herein, the photograph is either the Nominator's or Teacher's own, produced by either Nominator or Teacher; (ii) the photograph does not contain any computer virus (as applicable), is otherwise uncorrupted, is wholly original and is not the subject of any actual or threatened litigation or claim; (iii) the photograph does not and will not violate or infringe upon the intellectual property rights or other rights of any third party; and (iv) the photograph does not and will not violate any applicable laws, and is not and will not be defamatory or libelous. Each Nominator and Teacher hereby agrees to indemnify and hold the Released Parties harmless from and against any and all third party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of Entrant hereunder.

9. LICENSE

a. By entering the Contest, all Nominators and Teachers grant an irrevocable, perpetual, worldwide non-exclusive license to Released Parties, to reproduce, distribute, display and create derivative works of the Submission in connection with the Contest and promotion of the Contest, in any media now or hereafter known, for no additional compensation, including, but not limited to: display on Station's and Contest Sponsor's owned-and-operated websites and social media sites of all Submissions. The rights granted shall include, without limitation (i) all reproduction, distribution, adaptation, performance, fixation, rental and lending rights, exhibition, broadcast and all other rights of communication to the public; (ii) the right to make changes to the photographs, and to use such photographs as Station shall from time to time determine in its sole discretion; and (iii) the right to authorize, prohibit and/or control the renting, lending, fixation, reproduction, importation and/or other exploitation of the photograph as may be conferred under any applicable laws, regulations or directives.

b. Nominator and Teacher consent to Station doing or omitting to do any act that would otherwise infringe the Nominator's or Teacher's "moral rights" in the Submissions. Display or publication of any Submission on a Released Party's website does not indicate the Teacher will be selected as a Winner. Released Parties will not be required to pay any additional consideration or seek any additional approval in connection with such use as authorized by the License. Additionally, by entering, each Nominator and Teacher grants to Released Parties the unrestricted right to use all statements made in connection with the Contest, and pictures or likenesses of Contest Nominator or Teacher, or choose not to do so, at their sole discretion, except where prohibited by law. Released Parties will not be required to pay any consideration or seek any approval in connection with such use.

10. PRIVACY

a. By participating in the Contest and/or accepting prize(s), Nominator agrees to the Station's Terms of Use Agreement and to the use of Nominator's and Teacher's personal information as described in the Privacy Policy located at https://fm100.com/. In the event of conflict between the Station's Terms of Use Agreement and these Official Rules, the terms of these Official Rules shall apply. Any information that Twitter, Facebook, or Instagram collects through an entry in the Contest may be subject to Twitter's, Facebook's, or Instagram's own terms and policies.

11. COPY OF OFFICIAL RULES

- a. Any violation of these rules will result in disqualification. Consistent with Section 1(c), only one (1) Submission per Nominator per eligible Teacher is permitted. Any attempt by any one or more Nominators to obtain more than one (1) Submission by using the same email address, Twitter, Facebook, or Instagram account or similar registration method through any means including, without limitation, multiple/different email addresses, Twitter, Facebook, or Instagram accounts, identities, registrations, logins or other methods will void all Submission from that address or account, and such Nominator(s) will be disqualified.
