- 1. HOW TO ENTER
  - a. These rules govern the FM 100.3 Secret Sound 2020 ("Contest"), which is being conducted by KSFI-FM ("Station"). The sounds ("Secret Sound") have been created and approved by the Station and its management. The Contest begins on September 7, 2021 and will end on or before September 24, 2021, ("Contest Dates"). Entrants, as defined below, may enter on-air only.
  - b. To enter the Contest, the person entering the Contest ("Entrant") may enter on-air beginning on September 7, 2021 at 8:20 a.m. (MDT) and ending on or before September 24, 2021 at 4:20 p.m. (MDT), ("Entry Period"). This contest will not run on recognized holidays.
    - i. To enter on-air, listen to the Station each weekday starting on September 7, 2021 at 8:20 a.m. (MDT), 9:20 a.m. (MDT), 11:20 a.m. (MDT), 1:20 p.m. (MDT) and 4:20 p.m. (MDT) during the Entry Period for the on-air personality to play one second of a song. Upon hearing the one second of the song, the tenth (10<sup>th</sup>) designated caller or Entrant to get through to the Station contest lines: 801-575-1100 will have the chance to guess the Title of the song. The Entrant will have one (1) chance to guess the of the song. The Entrant's first guess is their final guess and must be exact to win. The on-air personality may, from time to time, announce clues. In the event there is a dispute over the guess being correct or close to the correct Title of the song the Station, at its sole discretion, will decide the validity of the Entrant will be required to provide all information requested auess. including Entrant's full name, complete address (including zip code), day and evening phone numbers, email address, and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple Entrants are not permitted to share the same phone number, and only one phone number may be used per Entrant.

- ii. Each song starts at \$500 and goes up \$50 with every wrong guess. Once that song hits \$1000 the station will start giving you clues on the FM100.3 Instagram Story. The prize amount will be \$500.00 at the start of the Contest on September 7, 2021. If an Entrant does not guess the correct artist of the song during a specific time slot indicated above, is disconnected, or is found to be ineligible, no prize will be awarded for that time slot and the amount of the prize will increase by an additional \$50.00 per time slot, for a total of \$250.00 per day. Once an Entrant guesses the correct Title and artist of the song the prize amount will go back to \$500.00. At no time will more than \$1,000.00 be awarded.
- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Only one (1) entry per Entrant is permitted.
- e. All entries must be received by the end of the Entry Period.
- 2. ELIGIBILITY RESTRICTIONS
  - a. The Contest is open to all persons who are legal U.S. residents of the state of Utah eighteen (18) years of age or older, and who reside in one of jurisdictions that make up the listening area in and around Salt Lake City, Utah. Void where prohibited or restricted by law.
  - b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above (i) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation to thers, and partners.
  - c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to entering the Contest are not eligible to participate.   - b. The Winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). Prizes are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for credit at any time, nor will they be replaced if lost or stolen.
  - c. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize(s). The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
  - d. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.
- 4. WINNER SELECTION AND NOTIFICATION
  - a. Decisions of the Station management with respect to the Contest are final.

- b. Up to a total of ten (10) Winner(s) will be selected on-air as described above in Section 1 of these Official Rules.
- c. Odds of winning depend upon the number and order of eligible phone calls received for each Secret Sound.
- d. Winners must listen to the Station to win but do not need to be present to win. All prizes must be picked up, claimed, or mailed within thirty (30) days of winning, as directed by the Station, including in-person, if public health conditions permit, at the office of the Station located at 55 North 300 West, Salt Lake City, Utah 84180 between regular business hours of 8:00 a.m.(MT) to 5:00 p.m. (MT), Monday through Friday. If public health conditions do not permit a Winner to claim the prize in person within thirty (30) days, the Station will coordinate with the Winner to confirm Winner's identity remotely and to deliver the prize by mail or other means of delivery. If the prize is mailed, the Winner will be required to sign a release that the Station and any Released Parties (defined below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping.
- e. Potential Winner(s) will be notified of winning by telephone. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. The Station's computer or telephone system is the official time keeping device for this Contest. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address; or (ii) is assigned to the mobile telephone number by a telecommunications provider, or

other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an Entrant's disqualification and/or forfeiture of any prize or prizes. - 7. COPY OF OFFICIAL RULES

Any attempt by any one or more Entrants to obtain more than one (1) entry by using the same phone number, email address, Twitter account or similar registration method through any means including, without limitation, multiple/different email addresses, Twitter accounts, identities, registrations, logins or other methods will void all entries from that address or account, and such Entrant(s) will be disqualified.
