- b. To enter the Contest, the person entering the Contest ("Entrant") may enter on-air beginning on FEBRUARY 8, 2023, at 1:00 AM (MST) and ending on MAY 30, 2023, at 11:59 PM (MST) ("Entry Period").
  - To enter online, visit www.fm100.com and follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Only one (1) entry per eligible person during the Entry Period, regardless if entrant has more than one email address. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.
- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Only one (1) entry per person is permitted.
- e. All entries must be received by the end of the Entry Period.

# 2. ELIGIBILITY RESTRICTIONS

a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older, and who reside in one of the jurisdictions that make up the listening area of Utah. Void where prohibited or restricted by law.

- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (i) any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to entering the Contest are not eligible to participate. a. One (1) prize will be awarded. The prize consists of two (2) tickets to see DURAN DURAN at VIVINT ARENA on June 3, 2023. The Approximate Retail Value ("ARV") of the prize is \$118.00. The prize does not include transportation or rental car, travel insurance, hotel room service, gratuity, parking fees, laundry service, meals, merchandise or souvenirs, local or long-distance telephone calls, service charges, taxes or any other cost or expense not expressly stated. Any difference between stated ARV and actual value will not be awarded. Certain restrictions may apply and is subject to hotel availability. Advanced reservations are required. The Winner's guests must be either eighteen (18) years of age or older or must be accompanied by a parent/legal guardian who is eighteen (18) years of age or older. The Station and Contest Sponsor assume no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station and Contest Sponsor are final.
- d. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

# 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Contest Sponsor and Station management with respect to the Contest are final.
- b. One (1) Winner will be selected as described above in Section 1 of these Official Rules. One (1) prize Winner will be selected on MAY 31, 2023 during business hours in a random drawing of all eligible online qualifying Winners during the Entry Period.
- c. Odds of qualifying for the grand prize depend upon the number and order of eligible online entries received. Odds of a qualifier winning depends on the number of entries received.
- d. All prizes must be picked up or claimed within three (3) days of winning, as directed by the Station, including in-person, if public health conditions permit, at the office of the Station located at 55 North 300 West, Salt Lake City, Utah 84180 between regular business hours of 8:00 AM (MT) to 5:00 PM (MT), Monday through Friday. If public health conditions do not permit a Winner to claim the prize in person within three (3) days, the Station will coordinate KSFI DURAN DURAN 2023 with the Winner to confirm Winner's identify remotely and to deliver the prize by mail or other means of delivery.
- e. Potential Winner(s) will be notified of winning by telephone or email. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. Upon notification or notification attempt, the potential Winner(s) will be required to respond to such notification attempt and must execute and return, along with the guest(s) of the Winner, an IRS Form W-9, affidavit of acceptance, eligibility, liability, publicity release, and if applicable, Contest Sponsor liability release forms within

The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address; or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but does not have the obligation, to cancel, terminate, suspend, or modify the Contest and shall not be required to award a substitute prize(s).
