 - i. Online Entrants are subject to all notices posted online including but not limited to the Station's Terms of Use and Privacy Policy. Limit one (1) daily entry per eligible Entrant during the Entry Period regardless if Entrant has more than one email address or Facebook account. Multiple Entrants are not permitted to share the same email address. PO Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.
- c. Due to delays in the online streaming of the Station's broadcast signal listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.

- e. There will be up to a total of one (1) winner selected in the Contest.

Decisions of the Station are final.

- C. The Entrant and Winner acknowledge and agree that all KSFI's broadcast-related content, and the date such content will air, is determined at the discretion of the news department of KSFI. Also, all Contest obligations are subject to preemption for breaking news and emergency new coverage.
- d. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

4. WINNER SELECTION AND NOTIFICATION
