 - i. To enter on-air listen for the cue to call during Brian Foxx's Nearly Impossible Question at 7:05AM during the Entry Period. When you hear it caller 10 at 801-575-1100 will win a prize upon confirmation of eligibility. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner.
 - ii. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.
 - iii. Entrants are required to provide truthful information to the Station and will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older. Void where prohibited or restricted by law.

5. CONDITIONS

- a.
