

The following contest is intended for participants in Utah only and will be governed by Utah laws. Do not proceed in this contest if you are not eligible or not currently located in Utah. Further eligibility restrictions are contained in the official rules below.

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. HOW TO ENTER

- a. These rules govern the KSFI JOHN LEGEND ON-AIR Contest ("Contest"), which is being conducted by KSFI ("Station"). The Contest begins on May 5, 2025 at 7:00AM (MT) and ends on August 23, 2025 at 1:00PM (MT) ("Contest Period"). Entrants may enter ON-AIR only during the following times ("Entry Period"):
 - i. To enter ON-AIR listen weekdays for the cue to call during the following Entry Period's:
 - March 31-April 4, 2025 during the 3PM hour with Rusty Keys
 - April 7-11, 2025 during the noon hour with Rebecca Cressman
 - ii. When the cue to call is announced, the designated caller at 801-575-1100 will win a prize upon confirmation of eligibility. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. PO Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner.
 - ii. There is no limit to the number of times a listener may attempt to call in to win during each designated Entry Period, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.
 - iii. Entrants are required to provide truthful information to the Station and will reject and delete any entry that it discovers to be false or fraudulent. The Station will

disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older, and who reside in one of the jurisdictions that make up the Utah DMA listening area. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter the Station contest at any time, even if such individuals meet the age and residency requirements above:
 - (i) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each.
 - (ii) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories.
 - (iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to the contest are not eligible to participate. Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to the contest are not eligible to participate. Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to the contest are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to the contest are not eligible to participate. These restrictions also apply to immediate household members of contest or Winners.
- d. This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

3. PRIZES

- a. Ten (10) ON-AIR PRIZES ("Prize") will be awarded. The Actual Retail Value (ARV) of each Prize is one hundred twenty dollars (\$120.00).
- b. Each Prize will consist of two (2) tickets to see John Legend: Get Lifted – 20th Anniversary Tour on 11/11/25 at the Maverik Center.
- c. All details of the Prize will be determined by Station in their sole discretion. Station reserves the right to substitute a similar Prize (or Prize element) of comparable or greater value. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of Prize are the sole responsibility of Winner. Prize cannot be transferred by Winner or redeemed for cash and is valid only for the items detailed above.

4. WINNER SELECTION AND NOTIFICATION

- a. Potential Winner will be notified of winning by telephone or email within 24 hours of the close of contest entry period. The Prize will be awarded only upon confirmation of eligibility and completion of all requisite releases. Upon notification or notification attempt, the potential Winner(s) will be required to respond to such notification attempt and must execute and return an IRS Form W-9, Station affidavit of acceptance, eligibility, liability, and publicity release **within 30 days of such notification or notification attempt or Prize will be forfeited**. If a potential Winner(s) is deemed ineligible for any reason, cannot be contacted, fails to sign and return the fully executed affidavit of eligibility and/or liability/publicity release within 30 days of prize notification, or if the Prize notification is returned as undeliverable, the potential Winner forfeits the prize(s).
- b. Prize will be emailed once winner forms are signed and tickets received at station from sponsor.

5. CONDITIONS

- a. Use of multiple email addresses or identities or of any robotic, automatic, or programmed entry method will result in disqualification.
- b. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the contest, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the contest, any such material changes will be broadcast on the Station and/or posted on its website: <https://fm100.com/contests/> within twenty-four (24) hours of the change and periodically thereafter.
- c. By entering the contest and/or acceptance of prize(s), all Entrants consent to the use of their name, photograph, likeness, biography, voice, video, entry materials, prize information (if any), or any statements made for trade, publicity, advertising, or promotional purposes, in any and all media, now known or hereafter devised, including online announcements, without limitation, and without compensation, except where prohibited by law.
- d. Each Winner will solely be responsible for any (federal, state, or local) taxes or fees that result from the receipt and/or use of their prize and may receive an IRS Form 1099-Misc for all prizes won from the Station in any calendar year where the aggregate value of all such prizes is \$600 or more.
- e. Participation in a contest and/or acceptance of prize(s) constitutes agreement by Entrant and/or Winner to forever discharge, indemnify, and hold harmless Station, its affiliates, parents, assigns, successors, employees, participating contest Sponsors, agents and all others connected with them, and the contest (the "Released Parties") from any and all liability, claims, actions, and damages sustained or incurred by participation in the said contest, and the receipt and use of any prize(s) awarded (if any) through such contest arising in any manner whatsoever, including but not limited to an act or omission, whether negligent, intentional or otherwise caused by Station, its affiliates, parents, assigns, successors, employees, sponsors, agents, and all others connected with them and the contest.

f. The Released Parties are not responsible for:

- (i) Typographical or other errors in the printing, the offering, or the administration of the contest or in the announcement of a prize.
- (ii) Incorrect or inaccurate information, human error, failure or omission.
- (iii) Lost, stolen, mangled, misdirected, illegible, incomplete, or late entries.
- (iv) Released Parties are not responsible if any part of a contest cannot be conducted and/or if a prize, either in whole or in part, cannot be awarded due to acts of God, acts of war, natural disasters, disease, epidemic, pandemic, national or regional emergency, weather, acts of terrorism, or other factors beyond the Released Parties' control.

g. Except where prohibited, by entering the contest, each Entrant agrees that:

- (i) Any and all disputes, claims and causes of action arising out of or connected with this contest or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in Salt Lake City, Utah;
- (ii) Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and
- (iii) No punitive, incidental, special, consequential, or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"); and
- (iv) Entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased. Utah law governs the interpretation and construction of these Official Rules and all aspects related thereto.
