- a. These rules govern the KSFI Brian Foxx's "Nearly Impossible Question" George Michael Reborn ON-AIR Contest ("Contest"), which is being conducted by KSFI ("Station"). The Contest begins on May 5, 2025 at 12:01AM (MT) and ends on May 9, 2025 at 9:00AM (MT) ("Entry Period"). Entrants may enter ON-AIR only.
  - i. To enter ON-AIR listen during Brian Foxx's Nearly Impossible Question at 7:05AM during the Entry Period. When the cue to call is announced, the designated caller at 801-575-1100 will win a prize upon confirmation of eligibility. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully makes it through on the call-in line and completes the call will be a winner.
  - ii. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.

- b. The following individuals are NOT eligible to enter the Station contest at any time, even if such individuals meet the age and residency requirements above:
  - (i) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each.
  - (ii) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories.
  - (iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. - c. All details of the Prize will be determined by Station in their sole discretion. Station reserves the right to substitute a similar Prize (or Prize element) of comparable or greater value. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of Prize are the sole responsibility of Winner. Prize cannot be transferred by Winner or redeemed for cash and is valid only for the items detailed above.

## 4. WINNER SELECTION AND NOTIFICATION

a. ON-AIR Winner's will be notified at the time of entrants call. The Prize will be awarded only upon confirmation of eligibility and completion of all requisite releases.
