- c. At the time of entrant's submission, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. PO Boxes are not permitted as addresses. In the event that the selected winner is found to be ineligible, that entrant will not win a prize and the next eligible entrant will be a winner. Only one (1) entry per person during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.
  - i. Do not submit a photograph that includes: sculptures, statues, paintings, other works of art, obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content. The photograph, in its entirety, must be a single work of original material taken by you. You represent, acknowledge, and warrant that the submitted photograph is an original work created solely by you, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph. By submitting your photograph you grant an irrevocable, perpetual, worldwide non-exclusive license to Bonneville International Corporation ("Bonneville"), its affiliates, parents, assigns, successors, and employees ("affiliates") to reproduce, distribute, display and create derivative works of the entries (along with a name credit) in connection with the promotional contest (the "Contest") and promotion of the Contest, in any media now or hereafter known, for no additional compensation, including, but not limited to: display at a potential exhibition;

published online highlighting entries in the Contest. You consent to Bonneville doing or omitting to do any act that would otherwise infringe your "moral rights" in your entry. Display or publication of any entry on any affiliated website does not indicate that you have won any prize. Bonneville and its affiliates will not be required to pay any additional consideration or seek any additional approval in connection with such use as authorized by you. You grant to Bonneville and its affiliates the unrestricted right to use all statements made in connection with the Campaign.

- d. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. - f. All entries must be received by May 9, 2025 at 12:00pm (MT).

#### 2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older, and who reside in Utah. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

The Station assumes no responsibility or liability for damages, loss, or, injury resulting from acceptance or use of the prize. The Station is not responsible for replacing gift certificates that have been awarded. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
- 4. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.

#### 5. WINNER SELECTION AND NOTIFICATION

The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes.
