### **OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW.

### **1. HOW TO ENTER**

- a. These rules govern the KSFI DISNEY ON ICE CONTEST ("Contest"), which is being conducted by KSFI ("Station"). The Contest begins on September 8, 2025 at 12:01AM (MT) and ends on October 31, 2025 at 11:59PM (MT) ("Entry Period"). Entrants may enter ONLINE or on the FM100.3 APP.
  - i. **To enter online**, visit <https://www.fm100.com/contests/> follow the links and instructions to enter the Contest and complete and submit the online entry form during the Entry Period outlined above.
  - ii. **To enter on the Arrow App**, download the FM100.3 App from the iTunes App Store or Google Play Store or this link: <https://fm100.com/mobile/> then follow the links to the Contest and complete and submit the online entry form during the Entry Period outlined above.
  - iii. Entrants are required to provide truthful information to the Station and will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.
  - iv. Limit one (1) daily entry per day per eligible person during the Entry Period, regardless if entrant has more than one email address. Ten (10) extra entries may be awarded for each friend who enters the contest if contest is shared on social media by Entrant. Multiple participants are not permitted to share the same email address or Facebook account. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator. Entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy
  - v. There will be one (1) Prize Winner selected at the conclusion of the contest.

### **2. ELIGIBILITY RESTRICTIONS**

- a. The Contest is open to all persons who are legal U.S. residents of the state of Utah, eighteen (18) years of age or older, and who reside in one of the jurisdictions that make up the Utah DMA listening area. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio station, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to the contest are not eligible to participate. Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to the contest are not eligible to participate. Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to the contest are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to the contest are not eligible to participate. These restrictions also apply to immediate household members of contest or Winners.
- d. To claim any prizes, the Winner(s) must provide valid government-issued photo identification and provide their complete address, date of birth and phone number, and Social Security Number.
- e. Entrants are required to provide truthful information to the Station and will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.
- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

### 3. PRIZES

- a. One (1) Prize ("Prize") will be awarded. The Actual Retail Value ("ARV") of the Prize is one hundred twenty dollars (\$120.00).
- b. **Prize will consist of four (4) tickets to Disney on Ice Frozen and Encanto at the Delta Center on Thursday, November 6, 2025.**
- c. All details of the Prize will be determined by the Station in their sole discretion. Station reserves the right to substitute a similar Prize (or Prize element) of comparable or greater value. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of Prize are the sole responsibility of Winner. Prize cannot be transferred by Winner or redeemed for cash and is valid only for the items detailed above.

### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. Odds of winning depend upon the number and order of eligible online entries received.
- c. Potential Winner(s) will be notified of winning by telephone within 72 hours of the close of contest entry period. The Prize will be awarded only upon confirmation of eligibility and completion of all requisite releases. **Upon notification or notification attempt, the potential Winner(s) will be required to respond within three (3) days of such notification or notification attempt or Prize will be forfeited.** If a potential Winner(s) is deemed ineligible for any reason, cannot be contacted, fails to sign and return the fully executed affidavit of eligibility and/or liability/publicity release within three (3) days after notification, or if the Prize notification is returned as undeliverable, the potential Winner forfeits the prize(s). The Station, Contest Administrator or Sponsor is not responsible for any changes in an entrant or Winner's email address, phone number, mailing address or other contact information.
- d. **Once winner forms are signed, tickets will be emailed.**

## 5. CONDITIONS

- a. Use of multiple email addresses or identities or of any robotic, automatic, or programmed entry method will result in disqualification.
- b. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the contest, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the contest, any such material changes will be broadcast on the Station and/or posted on its website: <https://fm100.com/contests/> within twenty-four (24) hours of the change and periodically thereafter.
- c. By entering the contest and/or acceptance of prize(s), all Entrants consent to the use of their name, photograph, likeness, biography, voice, video, entry materials, prize information (if any), or any statements made for trade, publicity, advertising, or promotional purposes, in any and all media, now known or hereafter devised, including online announcements, without limitation, and without compensation, except where prohibited by law.
- d. Each Winner will solely be responsible for any (federal, state, or local) taxes or fees that result from the receipt and/or use of their prize and may receive an IRS Form 1099-Misc for all prizes won from the Station in any calendar year where the aggregate value of all such prizes is \$600 or more.

in any manner whatsoever, including but not limited to an act or omission, whether negligent, intentional or otherwise caused by Station, its affiliates, parents, assigns, successors, employees, sponsors, agents, and all others connected with them and the contest.

f. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering, or the administration of the Contest or in the announcement of a prize; (ii) incorrect or inaccurate information, human error, failure, or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, illegible, incomplete, or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals or signal interference, accidental disconnection, equipment malfunctions, and any other technological failures. Further, the Released Parties are not responsible if any part of a Contest cannot be conducted and/or if a prize, either in whole or in part, cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism, or other factors beyond the Released Parties' control.

g. Each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Contest or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in Salt Lake City, Utah; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased. Utah law governs the interpretation and construction of these Official Rules and all aspects related thereto.
